Direction of Use

Drip: Use 0.75 - 1.25 L/1000 sqm (3 - 4 L/acre/application) with final dilution of 1:400- 500 (2-3 ml/L).

Drench: Use @ 1.5 – 2 L/1000 sq. meters.

Foliar: Use @ 1:250 to 1:300 (3-4 ml/L).
